Mexico Consolidates Labeling Requirements for Fruit Juices

Report Highlights:

The Secretariat of Economy (SE) published in the *Diario Oficial* (Federal Register), on March 11, 2011, a resolution that modifies the official regulation NOM-173-SCFI-2009 Pre-packaged Fruit Juices that was published originally on August 28, 2009. FAS/Mexico received indication that the Government of Mexico is updating a number of Mexican Official Regulations (NOMs) that must be brought into compliance with NOM-051-SCFI/SSA1-2010 General Labeling Specifications for Pre-packaged Food and Non-alcoholic Beverages.

General Information:

Introduction: This report summarizes an <u>announcement</u> from the SE published in Mexico's Federal Register on March 11, 2011. The announcement modifies and adds language to NOM-173-SCFI-2009 Pre-packaged Fruit Juices.

Title: Resolution that amends Articles 2, 3.10, 9, and 10; and adds Article 5.1.4 to NOM-173-SCFI-2009 Pre-packaged Fruit Juices - Name of the Product, Physical and Chemical Specifications, Commercial Information and Verification Methods

Executive Summary:

On March 11, 2011, SE announced amendments to NOM-173-SCFI-2009 Pre-packaged Fruit Juices, that was published originally on August 28, 2009, (see 2009 GAIN report MX9058 SE Approves Fruit Juice Regulation). The amendments update information, mainly on labeling, in order to comply with the new official regulations established on April 5, 2010. These amendments will enter into force on June 2, 2011. An unofficial translation of the relevant portions follows:

Beginning of translation.

Sections 2, 3.10, 9, and 10 are modified, and section 5.1.4 is added to the Official Mexican Standard NOM-173-SCFI-2009, published in the Diario Oficial on August 28, 2009, to read as follows:

2. Reference

This Mexican Standard is supplemented by the following Mexican Official Standards and current Mexican standards:

NOM-051-SCFI/SSA1-2010 General Labeling Specifications for Pre-packaged Food and Non-alcoholic Beverages, as published in the Diario Oficial on April 5, 2010.

3. Definitions...

3.10. Pre-packaged product

Fruit juices that are placed in a container of any kind, without the consumer present, and the amount of product contained therein cannot be altered unless the container is opened or changed significantly.

5. Classification and Commercial Naming...

5.1.4. The lettering of the trade name must be of the same typeface and size.

6...

9. Commercial Information

The labels of the products covered by this standard must comply with the labeling provisions established in NOM-051-SCFI/SSA1-2010, as indicated in the reference section of this NOM, as well as any specific provisions described in this standard.

10. Verification and Supervision

This Mexican Official Standard is not certifiable, however compliance will be verified and supervised by SE, the Federal Consumer Protection Agency (PROFECO) and the Federal Commission for Sanitary Risk Protection (COFEPRIS) as detailed in the scope of their authorities.

Additional Information

It is strongly recommended that U.S. food and agricultural product exporters review the complete text of the new NOM-051 to make sure that labels of pre-packaged food and non-alcoholic beverages exported to Mexico for direct to consumer retail sale are in compliance with current requirements. The publishing of this notice is an effort of the Government of Mexico to consolidate all labeling regulations with NOM-051. This is a welcomed effort which will remove confusion about labeling regulations when each of the NOMs contains conflicting labeling requirements. At this time, it is clear that NOM-051 will be the standard regulation used for labeling of consumer goods. For additional information, consult the GAIN Reports referenced, below.
