# **South Africa Pet Food Market Brief**

### **Report Highlights:**

South Africa has a well-developed pet culture and is a net importer of pet food products. The main opportunities are for dog and cat food in the retail sector, which has shown increasing sales over the past few years. In addition, South Africa is a gateway for regional markets, with growing consumer demand for pet food and pet related products continuing to drive imports.

#### SECTION 1. MARKET OVERVIEW

South Africa, a highly competitive market with a developed pet culture and pet industries, is a net importer of pet food products. Despite, the country economic hardships and pressure of a weakening exchange rate, according to the Global Trade Atlas statistics (GTA) FY16 imports totaled \$40 million and exports totaled \$22 million. Netherlands, the United States, and France are the main suppliers collectively, accounting for 75 percent of the total imports in FY16. Opportunities exist mainly for dog and cat food (HS 230910) in the retail sector, which has been characterized by increasing sales over the past few years. Supermarkets and wholesaler outlets stock a wide range of pet food and remain the most common distribution channel for dog and cat food with a smaller range of pet care products. Specialty stores or pet shops and vet shops stock premium food brands, including premium imported brands among other pet food.

The pet food industry is regulated by the Farm Feed Regulation Act 36 of 1947. U.S. exporters are allowed to export pet food into South Africa provided the products are registered in terms of the Farm Feed Regulation Act No. 36 of 1947 prior to importation. The registration holder can only be a company registered in South Africa or a South African citizen.

#### SECTION 2. MARKET SECTOR OPPORTUNITIES AND THREATS

## 2.1 Entry Strategy

South Africa presents opportunities as a gateway for regional markets, with growing consumer demand for pet food and pet related products continuing to drive imported pet food products.

The basic and most common distribution channel for pet foods in South Africa is through importers, retailers/supermarkets/hypermarkets outlets, wholesalers, specialty stores which include veterinarian shops and pet shops. Dog and cat goods are the biggest commodities within pet care, enabling supermarkets and retailers to dominate in terms of distribution. Pet food manufacturers maintain a wide distribution network across the mainstream channels to retailers, wholesalers and others, and may import other products directly or through their subsidiaries on a limited case, if not through an importer. Pet shops and vet shops stock both premium brands of dog and cat food as well as imported premium brands of other pet food products.

# 2.2 Company Profiles

The following is key information on major companies active in the sector, whose brands are accessible from South African major retail chains, and some of the wholesale outlets.

Mars Africa Pty Ltd: Mars <a href="www.mars.com/south-africa">www.mars.com/south-africa</a> is a manufacturer of dog treats and cat treats, dog and cat food. The company was formerly known as Master Foods South Africa, a wholly-owned subsidiary of Mars Inc., a family-owned company which is made up of four main divisions: namely chocolate, pet care, gum and packaged food. Master Foods was renamed Mars in 2008. This name change extended the company's presence within pet care on the back of a well-established global brand. Mars is known for its leading brands in pet food, such as Pedigree, Sheba, Perfect Fit and Whiskas. The company operates from three sites in South Africa: Johannesburg, Rosslyn in Pretoria and Montague

Gardens in Cape Town, with a wide distribution network across mainstream channels, including supermarkets and hypermarkets, with the majority of the products positioned in the mid-priced segment.

Foodcorp Pty Ltd: Foodcorp <a href="www.foodcorp.co.za">www.foodcorp.co.za</a> is a manufacturer and distributor of branded packaged food products. Foodcorp is a subsidiary of RCL Foods Limited (formerly Rainbow Chicken Limited), which is a diversified food producer in South Africa. Foodcorp operates seven production units namely, grocery, milling, baking, pie, fishing, beverage and specialty. Pet food falls under grocery, along with leading packaged food brands such as Yum Yum peanut butter, Nola condiments and Ouma rusks. The company's leading pet food brands include Bobtail, Ultra Dog, Dogmor and Catmor. Foodcorp positions its products across all price brands, targeting consumer of all income levels. Dogmor and Catmor cater mostly for the needs of low-to-middle income consumers and are available through Foodcorp's wide distribution network of major local retailers and supermarkets such as Pick n Pay, Spar, Shoprite-Checkers, Woolworths and Game, as well as independent and forecourt retailers at affordable prices.

Martin & Martin Pty Ltd: Martin & Martin www.bobmartin.co.za is a manufacturer of affordable medium priced dog treats and cat treats, dog and cat food, other pet food and premium pet products. The company is a privately owned independent South African company with more than fifty years of experience in the country, with a strong presence within pet food, health care, grooming and snacks and treats. Martin & Martin brands are available in major South African retail chains such as Shoprite, Spar and others with key brands such as Beeno, Bob Martin, Epol, and Lopis.

#### **SECTION 3. COSTS AND PRICES**

The following are some of the current retail selling prices of pet food products sourced from one of the major retail chains and wholesalers (Table 1). Prices are inclusive of 14 percent value added tax (VAT).

# **4.1 Barriers to Entry**

# **4.1.1 Tariff Barriers**

The import tariff duties on pet foods into South Africa as of December 19, 2016 are presented below (Table 2). VAT of 14 percent is payable on all imports and on locally manufactured products. VAT on imports is levied on the value of customs duty plus 10 percent.

#### 4.2 Non-tariff Barriers

#### 4.2.1 Regulation

Pet food in South Africa is subject to regulation under the Farm Feed Regulation Act 36 of 1947, <a href="http://www.nda.agric.za/doaDev/sideMenu/ActNo36\_1947/FF/Animal%20Feed%20Regulation.pdf">http://www.nda.agric.za/doaDev/sideMenu/ActNo36\_1947/FF/Animal%20Feed%20Regulation.pdf</a>, which is enforced by the Department of Agriculture, Forestry, and Fisheries (DAFF). The Act stipulates requirements aimed at ensuring safety, nutritional adequacy, and proper labeling of pet food. Additionally, to manufacture, import, or sell farm feed or pet food in South Africa, one must be registered in terms of the Fertilizers, Farm Feeds, Agriculture and Stock Remedies Act, <a href="http://www.gov.za/node/727474">http://www.gov.za/node/727474</a>. Importers must apply for an import permit license issued by DAFF, <a href="http://www.gov.za/services/fertilizers-farm-feeds-agricultural-remedies/import-farm-feed-and-pet-food">http://www.gov.za/services/fertilizers-farm-feeds-agricultural-remedies/import-farm-feed-and-pet-food</a>.
