## **Update - Exporter Registration Requirement**

#### **Report Highlights:**

Manufacturers and trademark owners of specific retail products being shipped to Egypt are now required to register with the Egyptian Ministry of Industry and Trade. The full decree, a list of impacted products and example documents are provided. The information below supersedes the January 2016 report.

#### **General Information:**

The Egyptian Minister of Industry and Trade issued a decree (992/2015), published on December 31, 2015, requiring foreign manufacturers of specific products to register for export with the Egyptian General Organization for Export and Import Control (GOEIC). This measure was superseded by a second decree (43/2016) published on January 16, 2016. Under Decree 43/2016, listed products will only be allowed entry into the Egyptian market if they are registered by the owner of the manufacturing facility or the legal holder of the trademark in advance. This decree entered into force on March 16, 2016.

The product manufacturer, trademark owner, or their legal representative may submit the application for registration in person or online (http://www.goeic.gov.eg/). US exporters are encouraged to apply in person, through a local representative, if necessary, to ensure proper submission of the required documentation. All documents submitted must be certified by the chamber of commerce at the location of issuance, legalized by the Egyptian embassy in the country of origin, and translated into Arabic. In addition to the application form, the following documentation is required:

#### Product manufacturers must provide -

- 1. A certificate verifying the existence and legal status of the facility.
- 2. A list of products manufactured at the facility and their trademarks.
- 3. A listing of trademarks owned by the manufacturer and any trademarks that are produced under license at the facility. (Note: factories producing goods under license should expect to provide documentation demonstrating that they are legally permitted to produce such goods.)
- 4. A certificate demonstrating that the facility has a quality control system in place. The certificate should be issued by an authority recognized by the International Laboratory Accreditation Cooperation (ILAC), the International Accreditation Forum (IAF), or from a recognized Egyptian or foreign governmental body approved by the Egyptian Ministry of Industry and Trade.

#### Owners of trademarks must provide –

- 1. A certificate verifying trademark registration and listing products produced under trademark.
- 2. A certificate from the trademark owner listing authorized distribution centers for the trademarked products.
- 3. A certificate demonstrating that the facility has a quality control system in place. The certificate should be issued by an authority recognized by the International Laboratory Accreditation Cooperation (ILAC), the International Accreditation Forum (IAF), or from a recognized Egyptian or foreign governmental body approved by the Egyptian Ministry of Industry and Trade.

Should there be any need to validate the information provided by the applicant, Egyptian authorities may request that a technical team visit the firm applying for registration. US exporters of affected products must comply with all Egyptian laws and regulations to ensure customs clearance. <u>Any products</u> arriving after March 16, 2016 will be subject to these requirements.

#### Concerning the Amendment of

The Rules Governing the Registration of the Factories eligible to export their products to Arab Republic of Egypt.

#### Minister of Trade and Industry

Upon review to Law No.118 of 1975 on Import and Export,

And Ministerial Decree No. 770 of 2005 on the Executive Regulation implementing the referred to Law No. 118 of 1975,

And the Ministerial Decree No. 992 of 2015 on The Rules Governing the Registration of the Factories eligible to export their products to Arab Republic of Egypt, and

According to the memorandum of Trade Agreements & Foreign Trade Sectors.

#### Decreed

#### (Article 1)

A record shall be created at the General Organization for Export and Import Control (GOEIC) for the factories and companies, the owners of the trade marks, eligible to export products listed in the attached statement to the Arab Republic of Egypt.

The imported products for trading purposes shall not be released unless they are produced in the registered factories, or imported from the companies own the mark, or the distribution centers, registered in this record.

Registry on this record or cancelation shall be by a decree from the competent Minister of Foreign Trade, and he may grant an exemption from any or all of the registration requirements in the cases determined thereby.

#### (Article 2)

#### Registration in the mentioned record could fulfill the following conditions:

#### First: for the factories:

The Registration form submitted by the legal representative of the factory, or whomever he delegates, or his agent supported by the following authenticated documents:

- The legal identity of the Factory, and the license issued for it.
- List of the products of the factory and its trademarks.
- The product trademark and the trademarks produced under license from their owners.
- A certificate that the factory applies a quality control system issued from a recognized body certified by one of the accredited bodies from the International Laboratory Accreditation Cooperation (ILAC) or the International Accreditation Forum (IAF) or an Egyptian or Foreign governmental entity approved by the competent Minister of Foreign Trade.

#### **Second**: for the companies the owners of the trademarks:

The Registration form submitted by the legal representative of the company the owner of the trademark, or whomever he delegates, or his agent supported by the following authenticated documents:

- A certificate with the registration of the trademark and the products produced under it.
- A certificate from the company -the owner of the mark- with the distribution centers allowed to supply the products of this mark.
- A certificate that the company –the owner of the trademark- applies a quality control system issued from a recognized body certified by one of the accredited bodies from the International Laboratory Accreditation Cooperation (ILAC) or the International Accreditation Forum (IAF) or an Egyptian or Foreign governmental entity approved by the competent Minister of Foreign Trade.

#### Third:

In case of doubting the validity of the documents introduced, it will not be registered in the record unless we get confirmed. The company or the factory — upon the request of the registered person - may accept inspection to ensure the validity of its documents, and this will be after the approval of the competent Minister of Foreign Trade.

## (Article 3)

It is canceled; all that contradicts or dissents with the provisions of this decree.

## (Article 4)

This decree shall be published in the Egyptian Official Gazette and shall enter into force after two months from the date of its publication.
